### I. Awards with an application process facilitated within the Dept.

#### **APA Dissertation Research Awards**

##### **Deadline(s)**

September, usually middle

##### **Description**

To assist students with research costs. The current program includes 30-40 grants of \$1000 each, along with several larger grants of up to \$5000 to students whose dissertation research reflects excellence in scientific psychology.

##### **Award Amount**

\$1,000-\$5000 used to support expenses directly related to research

##### **Other Requirements**

(1) Must have advanced to doctoral candidacy; (2) must include a research budget in the application. NOTE: the award must only be used to directly support research-related expenses; (3) must be selected by the Student Awards Committee as one of 3 departmental nominees. These nominees need to join APA as student affiliates if not already APA members.

##### **Deadline(s)**

February, usually the first week

##### **Description**

Travel awards for APA student affiliates invited to present research at the APA convention.

Must be selected as a nominee by the Departmental Student Awards Committee & must have already been invited to present at APA. Applications must first be submitted to the department nomination selection.

##### **Deadline(s)**

December, usually beginning

##### **Description**

For a student who will be enrolled at the time of application as well as during the Fall quarter of the year that follows; must have achieved distinction by outstanding study and research, and fine teaching combined with exemplary university citizenship

##### **Award Amount**

\$3,000

**Charles F. Scott Fellowship**

**Deadline(s)**

January, usually beginning

**Description**

For applicants enrolled in a course of study that prepares them for leadership in national, state, or local governmental administration, involvement in policy-making organizations, etc. Although this award may not appear to be intended for Psychology graduate students, the restriction in regard to the course of study is interpreted quite liberally. Students in the clinical, developmental, and social areas have regularly received this award.

\$15,000 (up to). Several awards

**Other Requirements**

Applicants must hold a B.A. OR B.S. from UCLA, although students from other UC campuses may be considered.

**Collegium of University Teaching Fellows Program (CUTF)**

**Deadline(s)**

February, usually middle

**Description**

Through the program, some of UCLA's very best advanced graduate students have the opportunity to develop and teach a lower division seminar in their field of specialization on a one-time only basis.

**Award Amount**

Fellows are paid a stipend and receive fee remission and insurance in the quarter in which they teach.

**Other Requirements**

Teaching fellows must have advanced to candidacy by the beginning of the fall quarter of the academic year in which they are planning to teach, but not yet graduated. The Committee's criteria for reviewing course proposals also suggest that the seminar be relevant to the graduate student's career plans and provide a link to the subject area of their dissertation research.

**Deadline(s)**

January, usually middle

**Description**

For graduate students in scientific fields related, allied, or of value to the medical field. Preference is given to entering graduate students, but continuing graduate students often receive this award.

**Award Amount**

\$15,000 (up to) from which registration fees are paid

**Other Requirements**

**Early Researcher Awards**

**Deadline(s)**

September, usually middle

**Description**

These awards recognize outstanding student researchers who are currently early in graduate training (i.e., this must be recently completed research, within approximately twelve months preceding the submission deadline). Up to three awards will be given in 2007, drawn from basic science, applied science, and/or interdisciplinary science areas. Submissions for research in progress will also not be accepted.

**Award Amount**

Each recipient will receive an award of \$1,000.

**Other Requirements**

Strong preference will be given to students who demonstrate outstanding research abilities earlier in their graduate training (i.e., up to and including the MA or equivalent—i.e., your 251 papers), and who show a considerable level of independence in conducting their research.

**Description**

For a truly distinguished dissertation. Doctoral committees are asked to nominate the top 10% of our students for this award.

Students who file their dissertations by the spring quarter filing deadline will be considered for the current year. Students who file after the deadline will be considered for the following year. The winner of this award will be announced at commencement and will be nominated for the New York Academic of Sciences James McKeen Cattell Dissertation Award.

**Graduate Division Dissertation Year Fellowship Program**

**Deadline(s)**

March, usually middle; ATC  
deadline: Mid April

**Description**

Fellowship support for students who expect to graduate at the end of the fellowship year, and who are planning to start teaching and/or research appointments soon after graduation.

**Award Amount**

\$17,500 stipend, a \$500 research allowance and mandatory fees

**Other Requirements**

1) Students must be conducting full-time dissertation research during fellowship year  
(2) Recipients who receive full funding may not have salary appointments exceeding 25% time during the fellowship year. (3) Students may not hold two major awards concurrently, or receive fee awards exceeding the actual amount covered by the Graduate Division or Alumni Association dissertation awards. (4) Must be advanced to candidacy and have completed all coursework, written, and oral exams prior to advancement to candidacy. Clinical students who will be in their final year of dissertation, but who will complete a year of internship after writing the dissertation, may request special consideration when applying for these awards.

**Description**

This program assists doctoral students in acquiring and developing sophisticated research skills under faculty mentorship. Faculty mentors are expected to assist student participants with research leading to the development of a doctoral

**Award Amount**

\$17,500 stipend + mandatory fees (excluding tuition) + \$500 toward travel expenses

**Other Requirements**

The program is open to doctoral students who - by the program's start - will have completed at least one year but not more than four years of graduate study. Students who have advanced to candidacy are not eligible. Applicants must be U.S. citizens or permanent residents.
